First	Champions with Performance (Obedience, Agility or Tracking) Titles
Second	Champions or Performance Titled Dogs
Third	All other Dobermans

Dogs with AKC Champion and/or Performance Titles must include copies of titles held as proof of eligibility and to ascertain priority for testing. Photostats will not be returned. Dogs must have an AKC or ILP # or must be AKC registerable. NOTE: Only dogs of an allowed color may participate and Z factored dogs may go through with proof of spay/neuter.

*******Dogs must be 18 months or older*******

All dogs should be pre-entered (any same day entries will be handled on a space available basis)

Closing date for pre-entries: April 13, 2011

Bitches in season will be tested last

Entry fee: \$25.00 per dog

Entry fee is non-refundable (unless entry is refused due to entry limit being exceeded)

No entry will be accepted without fee

AGREEMENT

By entering this dog I agree that the club holding this event, the Doberman Pinscher Club of Houston (DPCH), has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and the opportunity to have a dog or dogs evaluated in either the Working Aptitude Evaluation (WAE) or the Canine Good Citizen (CGC) evaluation, or both, I agree to hold DPCH, the Doberman Pinscher Club of America (DPCA), the American Kennel Club (AKC), along with the respective clubs' members, directors, governors, officers, and agents, as well as the owner, officers, and employees of the premises on which this event is held, and any provider of services that are necessary to hold this event, any employees or volunteers of the aforementioned parties, and any DPCA or AKC evaluator, evaluating at this event, harmless from any claim for loss or injury which may be alleged to have been caused either directly or indirectly to any person, property, animal, or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I personally assume all responsibility and liability for any such claim; and I further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I hereby assume the sole responsibility for and agree to indemnify, defend, and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself or on account of damage to property arising out of or in consequence of my participation in this event, however such injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person. **I AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, PARTICIPATION, OR ATTENDANCE AT THE EVENT BETWEEN THE DPCH, THE DPCA, THE AKC, THE OWNER OF THE PREMISES AND MYSELF OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE DPCH, DPCA, AND AKC BYLAWS, RULES, REGULATIONS, AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE DPCH, DPCA, OR AKC CHARTERS, BYLAWS, RULES, REGULATIONS, POLICIES, AND GUIDELINES.**
